The Library Board of the Pinckney Community Public Library will hold its regular Board Meeting on Thursday, October 28, 2021 at 9:30 a.m. This meeting will be held electronically pursuant to the Village of Pinckney Resolution No. 2021- 11 Declaring a Local State of Emergency for the Purpose of Permitting the Village Council and Other Public Bodies of the Village to Meet by Electronic and Telephonic Means. Pursuant to the Village of Pinckney's Declaration of a Local State of Emergency, the Library gives notice of the following:

1. **Reason for Electronic Meeting.** The Library Board is meeting electronically because the Pinckney Village Council declared a local state of emergency due to the substantial or high rate of COVID-19 transmission in the Pinckney Community. Resolution No. 2021- 11 allows for the Pinckney Library Board of Trustees to meet electronically for public safety reasons and to allow the public who cannot be physically present the opportunity to provide comment.
